Dear Political Party

Arbitration proceedings have been instituted by Advocate Lempaa Vincent Suyianka against Kenyan legislators, both in Parliament and the county assemblies, who served in the 2013-2017 and 2017-2022 terms of office, having been elected on the ticket of a political party or as an independent candidate, changed their political party membership status prior to the expiry of their legislative terms of office, and remained in occupation of legislative office, notwithstanding that Articles 103(1)(e) and 194(1)(e) of the Constitution declared such legislative offices vacant.

As a political party that was affected by one or more of your legislators resigning from your political party, and thereby being deprived of your political gains in the previous general election or by-election, you might want to participate in the arbitration. You are therefore being given the opportunity to register your interest in such participation, and are being requested to do so by 30th May, 2024.
